1. PAYMENT TERMS:

A \$100.00 non-refundable deposit is required to reserve a Hearts Delight Chocolate Fountain. To confirm this agreement, return one signed and completed copy of this contract along with the \$100.00 non-refundable deposit within 5 days of the reservation. The balance is due NO LATER than 30 days prior to the event and can be paid in cash or by check or money order. All checks should be made payable to: Hearts Delight Chocolate Fountains.

2. CANCELLATION: If the Client initiates the cancellation the deposit is non-refundable. Client will hold harmless Hearts Delight Chocolate Fountains in the event of illness, injury, act of God, or any other situation beyond control of Hearts Delight Chocolate Fountains. In the event Hearts Delight Chocolate Fountain must cancel the reservation for any reason, Client will be entitled to full return of deposit, and agrees not to pursue any other damages against Hearts Delight Chocolate Fountain or its owners resulting from the cancellation.

3. PROVISIONS: Hearts Delight Chocolate Fountains requires access to the desired set-up area at least 60 minutes prior to the scheduled start time. In addition, 60 minutes are required after the conclusion of the service period for take down and removal (this time doesn’t count toward the 3 hours of fountain service time). The Client is responsible for providing a sturdy, level table capable of supporting at least 150 lbs. Client is also responsible for providing two table linens that coordinate with their color scheme. Hearts Delight Chocolate Fountains requires at least one - 120 volt circuit within 10 feet of the desired set-up area that adheres to contemporary safety standards and supplies a dedicated 15-amp outlet. Once the chocolate fountain has been set up in the desired location, it cannot be moved during the event. Client accepts full responsibility and is liable for any damages, injuries or delays that occur as a result of failure to comply with these provisions. Hearts Delight Chocolate Fountains reserves the rights to use any picture(s) from the event in advertising.

4. LIABILITY: Client agrees to assume full responsibility and liability for any and all claims arising out of the use of the chocolate fountain or its fountain attendants. Hearts Delight Chocolate Fountains will not be held liable for any injury, allergic reaction, loss or damage directly or consequently arising out of the use or rental of the Chocolate fountain. Client will indemnify Hearts Delight Chocolate Fountains against, and hold Hearts Delight Chocolate Fountains harmless from all claims, actions, proceedings, costs, damages, and liability including attorney’s fees arising out of, in connections with, or resulting from the rental of a Hearts Delight Chocolate Fountain.
